



A Sit Down With Our New and Not-So New City and County Judges

St. Louis County Associate Circuit Court Judge Jason D. Dodson, Appointed to the 21st Circuit, Division 33 on March 31, 2016, by Governor Nixon

Where did you go to school? Kirkwood High School (1988), Bates College, B.A. in Philosophy (1992), Washington University Law School, J.D. (1996).

What is your favorite thing to do outside of work?

I enjoy spending time with my wife and our children. I have 4 kids, and my wife has 3 and all 7 are involved in a lot of sports.

Why did you want to become a judge?

I love people, so I wanted to become a judge in order to help people. The "Law" has always been a significant party of my life in that my Mother and Grandfather were both lawyers.

How is the Bench different from what you initially thought?

There is much more camaraderie amongst the judges than I would have anticipated. We consistently work together on matters and help each other often. Also, there is more administrative work behind the scenes than I anticipated.

Do you have any recommendations for lawyers who appear before you?

It is best if attorneys come to court prepared, act professional to each other and the litigants, and set expectations with their client early on so to avoid any surprises.

Where did you work prior to your appointment?

During law school, I worked at Legal Services of Eastern Missouri, Inc. as a student intern. In addition, I was a law student intern at Gray & Ritter, PC (1995-1996). Upon my graduating from Washington University School of Law in 1996, I started as an attorney for Gray & Ritter (1996-2000). Then, I worked as an attorney at Simon, Lowe & Passanante, LLC (2000-2002). Afterward, I became a sole practitioner until 2003. Next, I worked for a short time at Thomas J. Noonan, PC (2003). In 2005, I began working again for Legal Services of Eastern Missouri, Inc. as an in-house volunteer, then in 2006 became a staff attorney, and in 2008 became a managing attorney.

The one thing that lawyers do in court that drives me crazy is . . .

I dislike when attorneys interrupt each other, and act in a condescending manner towards one another.

What part of your legal career best prepared you for this job?

The time I spent at legal services practicing civil litigation in domestic law greatly prepared me for this position.

As a group, is there anything lawyers could do to help judges?

Attorneys could participate more in Pro Bono services which would be a great benefit to judges and the community.

A Sit Down With Our New and Not-So New City and County Judges

Where did you go to school? Southwest High School, UMSL – Bachelor of Science, St. Louis University School of Law.

Why did you want to become a judge?

After spending time as a public defender and prosecutor, I felt I could do more for our community by serving as a judge.

Do you have any recommendations for lawyers who appear before you?

Be prepared. Additionally, it is very helpful to get to know all of the court personnel and appreciate their duties and responsibilities.

What do you wish you knew when you were practicing that you know now as a trial judge?

As a trial lawyer your focus is your client and how the court's decision is going to affect your client or the case. As a trial judge you have a larger number of similar cases which allows you to have the benefit of knowing how a decision played out in other similar cases.

Who were some of your mentors throughout your career? Judges Floyd McBride, Jimmie Edwards, Michael Calvin and Maggie Neill.

Do you have any special preferences for hearings or trials? I strongly recommend that the attorneys request a pre-trial conference at least one week before trial. Please bring all pre-trial motions and issues.

Anything else we should know about you?

I am very proud of spearheading the GPS monitoring program for our Pre-Trial Release Program. This program has worked very well and allows individuals to be released without bond pending trial. Also, I am an Adjunct Professor at Webster University where I teach in the legal studies program.

Why did you want to become a judge?

While serving as a Guardian ad Litem, I had been approached by a number of judges who suggested that I should consider becoming a judge. Initially, I did not really consider applying since I didn't have the type of political connections that I thought were needed to be appointed to the bench. Nevertheless, I looked into it, applied and I was fortunate to be appointed to the bench on June 29, 2016 by Governor Nixon.

Is there anything you miss about the practice of law now that you are on the Bench?

There are times when I miss being an advocate. As a judge, we no longer advocate for one side or the other. We take the facts and apply them to the law.

Do you have any recommendations for lawyers who appear before you?

Be prepared and maintain a professional conduct by dressing well, acting in a professional manner and treating others with respect.

What do you wish you knew when you were practicing that you know now that you are on the Bench?

How to respectfully, yet firmly, respond to a judge who takes a position adverse to my position. In situations where the judge does not seem to accept your argument, it is important to respectfully point out the statute, case law or precedent which supports your position to allow the court to come to the correct conclusion.

Do you have any special preferences for hearings or trials? Attorneys should request a pre-trial conference at least one week before the trial and bring a draft of their proposed jury instructions.
